There are three main thrusts in the **Community Services** area and they are:

- **Community Programs**
Supervised Access and Volunteer Programs.
- **Community Partnerships**

Child Protection Services

A **“Children’s Aid Society”** in Ontario is a non-profit community agency legislated under the Child and Family Services Act, and legally mandated to protect children under the age of 16 from abuse and neglect. CAS’s in Ontario are funded by the Government of Ontario (Ministry of Children and Youth Services).

The **“Child and Family Services Act”** promotes the best interests, protection and well-being of children with key emphasis on early action, access to information and early permanency planning.

The function of a CAS is to investigate allegations or evidence that children who are under the age of 16 who may be in need of

protection and provide services to protect those children.

This program offers child welfare services to children and families who reside within the District of Rainy River, excluding First Nation communities,* and include:

- Intake Assessment
- Abuse/Neglect Investigation
- Protection of Children
- Community Information and Education.
- Kinship Care Home Assessments.

The **“Duty to Report”** abuse and neglect is a key component of the Child and Family Services Act, stressing that every person who

believes, on reasonable grounds, that a child is, or may be, in need of protection, must promptly report the belief and the information upon which it is based, to a Children’s Aid Society.

Children’s Services



Children’s Services provides residential care to children up to the age of 18, who cannot be cared for by their biological parents.

Children may be in care temporarily with the consent of their parents, or themselves if they are over the age of 12 years, by signing a Temporary Care Agreement. Society Wardship is also temporary but is ordered by the court. Crown Wardship is permanent and Family and Children Services assumes the duties and

responsibilities of parents for children under this court order. Former Crown Wards of the Society can continue to receive assistance until the age of 21.

This service is provided to those residing in the Rainy River District, but excluding those living on any First Nation within the District*.

Services include:

- Foster Care
- Adoption Services
- Extended Care & Maintenance

Developmental Services

Developmental Services provides support to children and their families, with the goal that each child will reach their highest potential and live as active members of our community.

Programs offered include:

Community Integration

A program for children ages 6-21 years who have been diagnosed as having a physical and/or developmental disability.

Family Relief

A program for families of children who have been diagnosed as having a physical and/or developmental disability.

Infant/Child Development

A program for children ages 0-6 years and their parents. Parenting and developmental support is available for all families as well as those who have been diagnosed or are at risk for a physical, developmental, or sensory delay.

Children’s Mental Health Services

Children’s Mental Health Services assists children, adolescents, and their families who may be experiencing emotional, social, and/or psychological problems in their school, family and/or community life.

Services are provided free of charge, for a wide range of difficulties from mild adjustment reactions to severe psychiatric problems in children ranging in age from birth up to 18 years of age. Services include:

- Psychometric Assessments
- Suicide Risk Assessments
- Family Counselling

- Individual Counselling for Children
- Support for Children in an Education Program
- In-School Counselling
- Court-Ordered Assessment
- Groups

How to Get Service

Referrals should be made by the parent or guardian. However, referrals can also be made by other service providers (e.g. schools, doctors, etc.) with the parent’s consent. In addition, children 12 years or older can also make self-referrals.
